The undersigned law enforcement officer, of the Fond du Lac Sheriff, being first duly sworn, states that:

**Count 1: BURGLARY OF A BUILDING OR DWELLING**

The above-named defendant on or about Saturday, November 16, 2019, at N7745-77 HWY 151, TAYCHEEDAH, in the Town of Taycheedah, Fond du Lac County, Wisconsin, did intentionally enter a building,, without the consent of the person in lawful possession of the place, and with intent to steal,, contrary to sec. 943.10(1m)(a), 939.50(3)(f) Wis. Stats., a Class F Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

**Count 2: MISDEMEANOR THEFT**

The above-named defendant on or about Saturday, November 16, 2019, at N7745-77 HWY 151, TAYCHEEDAH, in the Town of Taycheedah, Fond du Lac County, Wisconsin, did intentionally take and carry away the movable property of Janon Baker, without consent and with intent to permanently deprive the owner of possession of the property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 3: CRIMINAL DAMAGE TO PROPERTY**

The above-named defendant on or about Saturday, November 16, 2019, at N7745-77 HWY 151, TAYCHEEDAH, in the Town of Taycheedah, Fond du Lac County, Wisconsin, did intentionally cause damage to the physical property of another without that person's consent, contrary to sec. 943.01(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 4: MISDEMEANOR THEFT**

The above-named defendant on or about Saturday, November 18, 2019, did obtain title to property of Greater Milwaukee Coin, by intentionally deceiving the person with a false representation which he knew to be false, made with intent to defraud, and which defrauded the person, contrary to sec. 943.20(1)(d) and (3)(a), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 5: MISDEMEANOR THEFT**

The above-named defendant on or about Saturday, November 17, 2019, Wisconsin, did obtain title to property of Half Price Books, by intentionally deceiving the person with a false representation which he knew to be false, made with intent to defraud, and which defrauded the person, contrary to sec. 943.20(1)(d) and (3)(a), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 6: MISDEMEANOR THEFT**

The above-named defendant on or about Saturday, November 16, 2019,, did obtain title to property of Mega Media Xchange, by intentionally deceiving the person with a false representation which he knew to be false, made with intent to defraud, and which defrauded the person, contrary to sec. 943.20(1)(d) and (3)(a), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**PROBABLE CAUSE:**

On Thursday, November 21, 2019, DEPUTY A. DOWLAND, of the Fond du Lac County Sheriff's Office dispatched for a burglary complaint at Secure Storage located at N7745 Hwy 151, Unit 77, in the Township of Taycheedah, Fond du Lac County, State of Wisconsin. The complainant, JANON BAKER, was at her residence at N10527 Hwy 151. When Deputy A. Dowland arrived at BAKER'S residence she met with a female who verbally identified herself as JANON BAKER. BAKER explained that in mid-September of 2019 she started renting a storage unit from Secure Storage. At that time she was assigned Unit 77. She also makes sure to lock her unit using a Brink padlock. Due to her going to the unit weekly she has it memorized due to muscle memory where everything is.

On 11-16-19, at approximately 6:30 p.m. BAKER went to the unit to retrieve her snow boots. When she pulled up to the unit she noticed the padlock was missing and the rope on the garage door was outside of the unit. BAKER was positive that is not how she left it. When she opened the garage door she immediately noticed that someone was inside of her unit. Boxes and totes of belongings were knocked over and things were rearranged. She briefly went through her items to see if anything was missing. BAKER discovered her black 18-gallon tote full of approximately 100 different movies/DVD's was missing. She thought this was odd considering there was high dollar electronic items in the wide-open. She said she knows what movies were in the tote because she has a good memory and she organized the movies in the tote herself. All of the movies are hers that she has had since the early 2000's. BAKER explained that some of the movies are mementos. BAKER served in the military, which required both her and her husband to serve overseas. During their tours overseas she bought movies from the local children so they could get food.

BAKER contacted MARY DEUSTER, who is the owner and manager of Secure Storage. DEUSTER told her she would check the surveillance cameras and get back to her.

On 11-21-19 DEUSTER called BAKER back with her findings. BAKER said she has not seen the video but DEUSTER explained the video shows the following. On 11-16-19, at approximately 3:30 p.m., a vehicle is in the parking lot of Secure Storage. The vehicle stops in front of Unit 77. A white male with a beard exits the vehicle, cuts the padlock, enters the unit, then later exits with a box in his hands. He puts the box into his vehicle and leaves. The video was able to obtain the license plate on the vehicle. It was a Wisconsin registration of AFC6300.

Deputy A. Dowland reports that BAKER valued the tote of movies at approximately \$1000.00 and the Brink padlock at \$10.00. She did not give anyone permission to enter her unit or take her items.

During investigation, Deputy A. Dowland ran the Wisconsin license plate of AFC6300 through the Department of Transportation. The license plate came back on a 2001 Toyota Camry, gold in color, registered to BRIAN T. ANDERSON, (DOB 03/22/1988) at 9102 W. North Ave., Apt. 2, in Wauwatosa, Wisconsin. Using the Northeastern Wisconsin Property Reporting System (NEWPRS) website, which provides information of items pawned at pawn shops, Deputy A. Dowland searched for ANDERSON'S name, and received numerous hits back. There was a BRIAN T. ANDERSON with the same date of birth of 3-22-88 and an address of 1320 Barrington Woods Dr. in the City of Brookfield, Wisconsin, that pawned items on 11-16-19, 11-17-19 and 11-18-19.

Deputy A. Dowland learned that on 11-16-19 at 7:17 p.m. at Mega Media Xchange located at 19555 W. Bluemound Rd., Brookfield, Wisconsin, suspect BRIAN ANDERSON sold 56 DVD's. On 11-17-19 at 11:29 a.m. at Half Price Books located at 5032 S. 74th St., Greenfield, Wisconsin, suspect ANDERSON sold 9 DVD's. On 11-18-19, at 1:01 p.m. at Greater Milwaukee Coin located at 4040 N. Calhoun Rd., Brookfield, Wisconsin, suspect ANDERSON sold miscellaneous broken jewelry and coins.

During investigation, Deputy A. Dowland made phone contact with Mega Media Xchange and spoke with an employee, SAM, who confirmed that ANDERSON sold items to the store on 11-16-19. When the store buys items they are held for 7 days before being put on the sales floor. It was later determined that the items sold totaled \$24.60. Deputy A. Dowland also made phone contact with Half Price Books, and spoke with TOM, the manager. TOM said ANDERSON was in the store on 11-17-19, in which he sold DVD's, board games and a book. The board games and book do not have to be entered into NEWPRS. TOM explained that the items are held for 11 days after being sold to the store. He was still in possession of all the items ANDERSON pawned. TOM put the items aside. He said he would work on getting me a copy of the surveillance video of ANDERSON inside of the store. It was later determined that the items were sold for a total of \$12.70

Deputy Dowland also spoke with co-owner Kenneth of Milwaukee coin. KENNETH recalled ANDERSON coming into the store on 11-18-19 because he appeared to know what he was talking about in relation to the gold coin he brought in. KENNETH recognized ANDERSON from being in the store previously. KENNETH still had the items ANDERSON sold to the store. These items were confiscated. The items consisted of two gold necklaces, a gold and multicolored butterfly charm, a gold dolphin charm, two silver clover pins, a 1940 United States of America quarter, a 1964 Unites State of America dime, a 1949 Canadian dime, a 1944 United States of America nickel, an 1849 gold United States of America coin. ANDERSON sold all the items for a total of \$110.00. KENNETH provided a copy of the surveillance video. In the video it appears that ANDERSON is wearing the same light blue colored velvet like jacket with a white furry collar that he was wearing in the video from Secure Storage. KENNETH provided a copy of the receipt that included ANDERSON'S driver's license and signature indicating he is the owner of the items

Deputy A. Dowland reports that it should be noted that the driver's license ANDERSON used on all the transactions was an expired Wisconsin driver's license with an address of 1320 Barrington Woods Dr. in Brookfield. Through investigation I have reason to believe that address is ANDERSON'S parents residence and ANDERSON resides at 9102 W. North Ave. in Wauwatosa.

The statements by law enforcement personnel are truthful and reliable as these statements were made within the scope of their official capacity. The statements made by Anderson are truthful and reliable insofar as these statements were made against his penal interests.

Based on the foregoing, the complainant believes this complaint to be true and correct.
