THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: FIRST DEGREE RECKLESS HOMICIDE, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Tuesday, November 23, 2021, at 1507 West Lincoln Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, did recklessly cause the death of Dominic Salas, another human being, under circumstances which showed utter disregard for human life, contrary to sec. 940.02(1), 939.50(3)(b), 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony **may** be increased by not more than 5 years.

Probable Cause:

Complainant is a City of Milwaukee Police Officer and bases this complaint upon his involvement in this investigation, as well as his review of police reports. That investigation and those reports revealed the following:

First Responding Officers

On November 23, 2021, City of Milwaukee Police Officers were dispatched to an incident at 1507 W. Lincoln Avenue, City and County of Milwaukee, State of Wisconsin. Upon arrival, officers found the body of the above mentioned victim, Dominic Salas. The victim had suffered a stab wound to the chest and life saving measures were not successful. The victim died of his injuries.

Autopsy

Complaint is further based upon the statement of Dr. Doug Kelley, an Assistant Medical Examiner with the Milwaukee County Medical Examiner's Office, who is trained and experienced in the field of forensic pathology and is duly licensed to practice medicine in Wisconsin. Dr. Kelley performed an autopsy on Dominic Salas and determined that he had suffered a stab wound to chest, as well as contusions to the left upper lip and dorsal right hand, and abrasions to the chin, right cheek, elbows, left hip and left forearm. Dr. Kelley determined that the cause of Mr. Salas death was stab wound to the chest.

Witness MC

Complaint is further based upon the statement of witness MC, who states that on the above date, at the above place, she had returned home when she heard a woman screaming. MC stated that she looked out her kitchen window and saw the victim laying on the sidewalk and saw the above mentioned Defendant, whom she identified through a photo array, kneeling beside the victim. MC stated that the Defendant said words to the effect of "I told you" and "that's what you get" while making a thrusting or stabbing motion with his arm towards the victim.

MC stated that she then saw a woman pulling the defendant off the victim and yelling, "stab me instead." MC stated that she yelled at the defendant to stop and told her husband what was happening. MC stated that he husband, , went outside to help.

MC also stated that she then saw the victim get up and walk towards to Lincoln Avenue and then collapse in the street. MC stated that she then saw the Defendant walking away while carrying a kitchen type knife with a blade of 3-4 inches.

Witness DC

Complaint is further based upon the statement of DC, the husband of MC, who stated that on the above date, at the above place, he heard yelling and observed people yelling outside. When he looked outside, DC saw the Defendant, whom he identified through a photo array, who was armed with a knife in an argument with two women and the victim.

DC stated that he heard a woman yell, "Stab me, stab me, don't stab me." DC stated that he then saw the Defendant grab the victim, start grappling with him, and then swing the knife towards the victim's upper body three or four different times.

DC stated that the victim then broke away and started running towards Lincoln Avenue, where he collapsed in the street. DC then ran to help the victim.
