THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON (As to defendant Bryanna J Johnson)

The above-named defendant on or about Sunday, January 30, 2022, at 12201 West North Avenue, Unit 201, in the City of Wauwatosa, Milwaukee County, Wisconsin, as a party to a crime, attempted to cause the death of AIR, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a), 939.32, 939.05, 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendants may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Count 2: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON (As to defendant Breanta Justice Johnson)

The above-named defendant on or about Sunday, January 30, 2022, at 12201 West North Avenue, Unit 201, in the City of Wauwatosa, Milwaukee County, Wisconsin, as a party to a crime, attempted to cause the death of AIR, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a), 939.32, 939.05, 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendants may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Probable Cause:

Your complainant is a City of Wauwatosa law enforcement officer and bases this complaint on reports generated by the City of Wauwatosa Police Department. On January 30, 2022, officers were dispatched to the George Webb Restaurant, located at 12201 W. North Avenue, #201, Wauwatosa, Wisconsin. Officer Alexander Herrera observed AIR DOB: 11/9/1995 who was lying on the ground next to the cash register. AIR had suffered a gunshot wound to the right side of his face. Officer Herrera interviewed JAW DOB: 1/13/1977. JAW stated that he is an employee of George Webb. JAW said that he observed four females sitting in a corner booth who were impatient and rude. JAW stated that the four females began arguing with JAW and AIR because their food was not getting served fast enough. JAW and AIR asked the women to leave the restaurant. JAW said that one woman, wearing a blue hoodie exited the restaurant briefly and then returned. The four women were up by the register and two of the women continued to argue with AIR. JAW attempted to separate AIR and the women. The woman in the blue hoodie punched AIR. The other woman pulled out a handgun and fired one round at AIR striking him in the face while AIR was lying on the ground.

Detective Kirk Will recovered and reviewed the surveillance video from the incident. Detective Will observed the following: At approximately 12:14 am individuals later identified as Bryanna Johnson (Defendant 1) and Breanta Johnson (Defendant 2) are near the front count with two other individuals. Defendant 2 was observed wearing a blue hooded sweatshirt, black pants, and black facial covering. Defendant 1 is observed saying something to Defendant 2 and Defendant 2 runs out of the restaurant. Defendant 2 reenters the restaurant a short time later. One of the individuals swings at AIR, but misses. Defendant 2 pulls a handgun from her waist area with her left hand. Defendant 2 hands the gun to Defendant 1. Defendant 2 punches AIR. Defendant 1 raises the handgun pointing it at AIR. Defendant 2 begins wrestling with AIR. AIR falls to the ground as Defendant 1 attempts to pistol whip AIR. AIR is lying on the ground when Defendant 1 extends her hand, aims, and shoots AIR in the face. Defendant 2 then stomps AIR in the face. All four individuals then flee the scene.

On February 3, 2022, HKW DOB: 8/22/2002, was interviewed after being read her *Miranda* Rights. During the interview, HKW was shown surveillance photos from the incident described above. HKW identified herself as being one of the individuals on scene. HKW also identified Bryanna Johnson as above described Defendant 1 and Breanta Johnson as above described Defendant 2. HW also stated that Defendant 2 retrieved a gun from the vehicle during the argument and heard someone "rack the slide" (charge the handgun) prior to Defendant 2 handing the gun to Defendant 1.

On February 4, 2022, Detective Kelly Zielinski interviewed Breanta Johnson after being read her *Miranda* Rights. Breanta Johnson stated, in part, that on January 30, 2022 she was at the George Webb Restaurant located at 12201 W. North Avenue, #201, Wauwatosa, Wisconsin. Breanta Johnson said that she and her group had a verbal confrontation with AIR. Breanta Johnson stated that she exited the restaurant, went to a silver Chevy Cruse, retrieved her handgun, and returned to the restaurant to confront AIR. Breanta Johnson said that the confrontation with AIR continued and she produced the handgun from her jacket pocket. Breanta Johnson stated that she punched AIR in the face, knocking him to the ground. Breanta Johnson said that after AIR was knocked to the ground, she kick AIR in the head. Breanta Johnson stated that she did not remember who or how the gun was taken from her during the altercation, stating she "blacked out" at that point during the fight. Detective Zielinski showed Breanta Johnson a still photo from the surveillance video. Breanta Johnson identified herself as the individual in the blue hooded sweatshirt, black pants, and black facial covering.
