**CRIMINAL COMPLAINT**

Defendant,

**The below-named complaining witness being first duly sworn states the following:**

**Count 1: FIRST DEGREE RECKLESSLY ENDANGERING SAFETY - PTAC, USE OF A DANGEROUS WEAPON**

The above-named defendant on or about Saturday, April 21, 2018, in the City of Madison, Dane County, Wisconsin, as a party to a crime, did recklessly endanger the safety of MAN, under circumstances which show utter disregard for human life, contrary to sec. 941.30(1), 939.50(3)(f), 939.05, 939.63(1)(b) Wis. Stats., a Class F Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

**Count 2: ARMED ROBBERY - PTAC**

The above-named defendant on or about Saturday, April 21, 2018, in the City of Madison, Dane County, Wisconsin, as a party to a crime, with intent to steal, did take property from the person or presence of the owner, MAN, by use or threatening use of a dangerous weapon, contrary to sec. 943.32(2), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 3: FELONY BAIL JUMPING**

The above-named defendant on or about Saturday, April 21, 2018, in the City of Madison, Dane County, Wisconsin, having been charged with a felony and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his

bond to wit: He did possess a dangerous weapon in violation of his bond in Dane County Case 2018CF000682, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**FACTS:**

Your complainant is a Detective with the City of Madison Police Department and for this complaint is relying on the official written police report submitted by City of Madison Police Officer Justin Cumley, Detective James Grann, and Detective Glenn Davis, Officer Shane Olson, and Detective Justine Harris.

Officer Cumley reports on April 21, 2018, at 9:39 P.M., he and other officers were dispatched to Famous Dave's, located at 900 South Park Street, in the City of Madison, Dane County, Wisconsin, for a report of a subject who had been shot at that location. Dispatch advised that the patient, who identified himself at that time as Tommie Lezy, had been outside and someone drove by and shot at him. Dispatch advised that the patient was now located inside the business.

Officer Cumley reports that the patient, who Officer Cumley later correctly identified via his State of Illinois Identification Card with a name that forms the initials MAN, was transported to St. Mary's Hospital by ambulance.

Upon arrival on scene, Officer Cumley met with an Associate Manager at Famous Dave's, who was identified with a name that forms the initials CLS. CLS advised that she was working this evening, April 21 2018, at Famous Dave's on Park Street, in the City of Madison, Dane County, Wisconsin. CLS explained that the man identified as MAN came into the business at approximately 5:30 P.M., and asked for an application. CLS stated that they were very busy and MAN asked them three times for an application, which he received. CLS stated that MAN never filled out the application, which she thought was strange, as he asked for it several times. CLS stated when MAN came into the business to get the application, she did not notice an injury to his left leg or observe him limping.

CLS further explained informed me that MAN came back to the business at approximately 9:00 P.M. CLS stated that shortly before contacting the police, an employee informed her that a subject came into the business and said he got shot and requested an ambulance. CLS met with MAN who came into the business, and he showed her his left thigh. CLS observed a gash on the front portion of MAN's left thigh. CLS also observed a gash on the back portion of MAN's left thigh. CLS stated that MAN told her he was in the business charging his cell phone and he walked outside and somebody drove by and shot at him. CLS did not observe a lot of blood on MAN's pants when she was speaking with him.

Officer Cumley reports he and Officer Pine responded to St. Mary's Hospital and made contact with MAN, who was being treated in Room 5 of the emergency department. Medical staff advised they needed to complete X-rays and a CT scan of MAN's left leg. Officer Cumley reports that once MAN's medical procedures were completed, ER staff informed that MAN had no major damage to his muscles or blood vessels in his left thigh. Medical staff stated MAN

would not need surgery and he would be released from the hospital and instructed how to treat the wounds with soap and water.

Officer Cumley reports he spoke with MAN. MAN explained he was at Famous Dave's charging his cell phone and he came outside and somebody shot at him. MAN informed that he was outside in the parking lot of Famous Dave's and he was walking towards a bus stop located on South Park Street. MAN stated that several vehicles were driving northbound and southbound on South Park Street when he was walking in the parking lot. MAN informed that as he was walking in the parking lot, he heard a "pop pop." MAN stated he felt a pain in his leg and he fell down onto the ground.

MAN stated he was unsure who shot him. MAN stated he did not see the vehicle, which was involved in the drive-by shooting. MAN stated he thought the subject who shot at him was in a vehicle that was traveling southbound on South Park Street, past the business. MAN stated after he was shot, he went into the business and asked them to call an ambulance.

Officer Cumley reports while in contact with MAN, he located a State of Illinois Identification Card for MAN, stuffed near the toe area inside MAN's left tennis shoe. Once it was determined that the name MAN provided of Tommie Levy was inaccurate and his actual name was MAN, Officer Cumley asked him why he gave a false name. MAN stated he used a fake name because he was scared as this has never happened to him before.

MAN explained that his friend, who he identified with a name that forms the initials DJP works at Famous Dave's at the Park Street location, in the City of Madison, Dane County, Wisconsin. MAN stated he had called DJP and asked if he could give him a few dollars. MAN informed he walked around to the west side of the business where the employee entrance was to see if DJP was coming out to meet him. MAN stated DJP did not come outside so he walked back around to the front of the business. MAN stated he was walking through the parking lot and was headed towards a bus stop located on South Park Street, when he heard, "Pop pop." MAN stated he felt a pain in his leg and he fell down, at which point he realized he had been shot. MAN believed the subject who shot at him was located in a vehicle that was traveling southbound on South Park Street, past the business. MAN stated he did not observe who shot at him and he has no idea who would have shot at him. MAN stated he was not shot at a different location and he was shot in the parking lot of Famous Dave's. MAN also informed that the injury to his leg was not a self-inflicted gunshot wound.

Officer Cumley reports Investigator Haggerty responded to the hospital and photographed the injuries to MAN's left thigh. MAN had an injury to the front portion of his left thigh. The injury was an open wound, which was about the size of a nickel. The skin around the open wound appeared burnt. MAN had another open wound, which was approximately the size of a dime, located on the side of his left thigh. The skin around the open wound was black and appeared burnt. It appeared as if the wound was an entry and exit wound from a bullet. Investigator Haggerty also photographed MAN's pants. MAN's pants had dried blood on them and a hole located on the front left pants leg and a hole on the back left pants leg near the pocket. Officer Cumley later collected MAN's pants as evidence and turned them over to Officer Pine.

Officer Cumley reports MAN was placed under arrest for an active warrant for his arrest. While waiting in the sally port, MAN was handcuffed and was seated in a chair. MAN stated that he wanted to be honest and tell the officers what had actually occurred. MAN stated this entire

situation started with a girl who called him and asked for some marijuana. MAN stated he told the girl who contacted him that he knew somebody that had marijuana. MAN stated the girl who contacted him asking about marijuana, said the marijuana was for her friend. MAN informed that he did not know the name of the female subject who called him and said the marijuana was for her friend. MAN stated he contacted somebody who had marijuana and arranged for that subject to come to Famous Dave's to provide the marijuana to the female subject's friend. MAN and another subject who had the marijuana met at Famous Dave's. MAN was unwilling to provide any information about the subject who brought the marijuana to Famous Dave's. MAN stated that a separate female subject contacted him via text message when they arrived at Famous Dave's and he and the male subject who had the marijuana got into a dark colored 4-door Chrysler 300M. MAN stated the Chrysler was parked on the west side of the building near the employee entrance. MAN stated he was seated behind the driver in the backseat and the male subject with the marijuana was seated in the rear passenger seat.

MAN further explained that the two subjects in the front seats of the vehicle looked at the ounce of marijuana. MAN stated that the male subject located in the front passenger seat of the vehicle then pulled out a black handgun, which had an extended clip and said something to the effect of, "Give me everything." MAN informed that when the male subject pulled a gun on him, he opened up the rear passenger side door, rolled out of the vehicle, and dropped to the ground. MAN stated that while lying on his stomach on the ground, he heard the gun being fired and realized he had been shot in the leg. MAN stated the other subject, who was seated in the rear passenger seat of the vehicle ran away from the vehicle and as far as he knew, the subject was not shot.

Officer Cumley reports MAN was taken into an interview room located off of the booking room. Officer Cumley asked MAN if he would be willing to allow Officer Cumley to review his cell phone call logs and text messages to obtain the phone numbers of the subject he was communicating with regarding the marijuana. MAN stated he was willing to provide the phone numbers of the subject he was communicating with. Officer Cumley allowed MAN to access his cell phone call log and he showed Officer Cumley a text message conversation he was having with a subject who had the phone number of (608) 209-9656. MAN did not allow Officer Cumley to review the text message conversation; however, informed this was the female subject who originally contacted him and stated she was trying to obtain some marijuana for her friend.

MAN allowed Officer Cumley to review a text message conversation he had with a subject who had the phone number of (773)322-3316. MAN stated this was the female subject who was obtaining the marijuana from the person he knew. Officer Cumley reviewed the text message conversation MAN had with the phone number (773)322-3316. On Saturday, April 21, 2018, at 7:38 P.M., MAN received a text message from (773)322-3316 which said, "This her friend, how much you want for the zip." MAN replied, "200. I got gas, no Madison shit, my come from Chicago, I travel for mines, how much u pay for this Madison loud, I got real gas." The subject replied, "Ok, I gotchu with the 200 cus u fuck wit my best friend." MAN replied, "Ok but y the face when u wont it." MAN sent a text message to (773)322-3316 on April 21, 2018, at 8:41 P.M., which said, "The liquor store close at 9 so where u at."

Detective Grann reports on April 25, 2018, and April 30, 2018, he reviewed jail calls made by MAN while he was incarcerated at the Dane County Jail, in the City of Madison, Dane County,

Wisconsin. Detective Grann reports on April 22, 2018, at 17:20:49, MAN made a call and spoke with an older female subject who he referred to as "Ma." The female subject asked MAN, "Who was the one, who shot you?" MAN responded, "I don't even know. They tried to rob me. It was a robbery." MAN told the female that he was shot while he was getting out of a vehicle during the course of this robbery. MAN told the female that he had an "ounce and money" stolen from him. The female subject asked MAN, "Did you see the guy?" and MAN responded, "Yeah, I saw the guy."

Detective Grann reports on April 26, 2018, at approximately 2:45 P.M., he spoke with MAN. MAN stated that his friend DJP picked him up and brought him to Famous Dave's in the City of Madison, Dane County, Wisconsin, where DJP was scheduled to work that evening. MAN stated that he then ate at Famous Dave's around 6:00 P.M. or 7:00 P.M., on April 21, 2018. MAN confirmed that a couple hours after he ate, he was still at Famous Dave's when he received a call and a text message from a female who was interested in obtaining marijuana. MAN stated that his own Android phone number was 312-468-7553. MAN stated that he did not recall the female's contact phone number. MAN stated he had originally first met this female on Leopold Drive several weeks earlier. MAN stated he did not recall this female's name. MAN stated they exchanged phone numbers at that time. MAN then clarified that during his contact with this female while he was at Famous Dave's, the female told him that her best friend wanted some "weed." MAN stated that the second female (presumably) then texted him from another phone number. MAN stated that he offered to sell this second subject an ounce of marijuana for \$175 or \$200. MAN stated he also negotiated the possibility of attempting to purchase alcohol for the females.

MAN stated that sometime after 9:00 P.M., a black male and a black female pulled up alongside Famous Dave's in a Chrysler 300M (color unknown by MAN). MAN stated the female was driving the vehicle and the black male was sitting in the front passenger seat. MAN stated that he had never met either of these subjects before, and he assumed that the female was the female subject that the other female had directed him to during their earlier phone communication. MAN indicated that another male subject got into the rear passenger side seat, and was subsequently seated beside him. MAN would not tell Detective Grann the identity of this fourth subject. It became clear to Detective Grann that the fourth individual was the supplier of the suspect marijuana and that MAN was articulating that he had attempted to middle this marijuana deal between the supplier and the intended buyer.

MAN further explained that the female that drove the four of them to the rear of the parking lot area, near an employee entrance/exit. MAN stated he handed the front seat passenger the ounce of marijuana. The male and female suspects then examined the marijuana for a brief period of time. MAN stated the male suspect in the front passenger seat then produced a .9mm semiautomatic handgun with an extended magazine. MAN stated that he was shocked that he and the other subject were being robbed for such a small amount of marijuana. MAN stated the male suspect demanded more items (phones and/or money) from MAN and his unidentified friend. MAN stated the suspect then struck his friend several times with the handgun. MAN stated that neither he nor his friend gave the suspects anything other than the marijuana that they already had. MAN stated that his friend got out of the vehicle's rear passenger side door of the vehicle and fled from the area on foot. MAN stated he himself rolled out of the rear driver side door and momentarily lay on the ground. MAN stated that while lying on the ground, he heard a gunshot and felt himself struck by a round on the outside

of his left thigh. MAN stated that he then got up and went inside of Famous Dave's to seek assistance.

**FOLLOW-UP ON PHONE NUMBERS OF INTEREST:**

Detective Grann reports he checked Dane County Jail records, which showed that on April 8, 2018, a man who was identified as Juwan J. Wilson, black male, date of birth March 20, 1997, the defendant herein, indicated that his phone number was 773-322-3316. Detective Grann checked City of Madison Police Department records, which showed that on May 5, 2018, Wilson was contacted by Madison Police reference a Check Person report (ref. case number 18-161072). On this date, Wilson again indicated that he had the same phone number. Detective Grann reviewed a Fitchburg Police Department report (ref. case number 18-4570) in which Wilson was arrested (thus his incarceration on that date) after being involved in a domestic incident with his girlfriend, ZNJ on Leopold Way. Detective Grann noted that MAN had previously informed Detective Grann that he had met the female, who gave him the phone number 608-209-9656 (in his contacts under "C"), in the area of Leopold Way. Through City of Madison Police Department records, Detective Grann found that on May 5, 2018, ZNJ told officers that her phone number was 608-209-9656. It therefore appeared as though MAN was communicating with ZNJ (or someone using her phone), before ZNJ (or someone using her phone) gave MAN ZNJ's boyfriend's, Juwan Wilson's, the defendant's, phone number, representing Wilson's number as being the female "best friend" who wanted marijuana.

Detective Grann reports on May 21, 2018, at approximately 9:55 A.M., Detective Grann called the phone number 608-294-0197, which had the contact name of Jmal associated with it. Detective Grann received an automated message that began with the prompt, "Welcome to Verizon Wireless". The message went on to indicate that this number has been changed, disconnected or was no longer in service. Detective Grann then made phone contact with Chris LNU at Verizon Wireless. Chris confirmed that this number was held by Verizon Wireless on April 21, 2018, and has been held by Verizon Wireless since 2016.

Detective Davis reports he was informed by Detective Grann that the defendant, Juwan Wilson, was on electronic monitoring at the time of the April 21, 2018, weapons offense, and requested that Detective Davis follow up with Rebecca Trollinger (Social Worker for Alternatives to Incarceration) to obtain additional information on Juwan Wilson's GPS. On May 30, 2018, at approximately 2:00 P.M., Detective Davis made contact with Trollinger at her office located in the City County Building, in the City of Madison, Dane County, Wisconsin. Detective Davis reports he was working in his official capacity as a Detective with the City of Madison Police Department.

Detective Davis reports Trollinger told Detective Davis that the defendant's, Juwan Wilson's, GPS electronic monitoring tracking device serial number had been 34403893.

**OVERVIEW OF PLOTTED GPS LOCATIONS FOR DEVICE 34403893 ON 04/21/18:**

Detective Davis noted that the following is an overview of the recorded GPS locations during the time frame immediately before and after the weapons offense on April 21, 2018, shown to Detective Davis by Trollinger on the GPS mapping software.

Detective Davis reports Trollinger reported that on April 21, 2018, Juwan Wilson's, the defendant's, GPS recorded a location approximately every one minute. Trollinger displayed the GPS plots on map and showed the GPS traveled East on Highway 30, South on Highway

51, West on the Beltline until exiting North on South Park Street. Trollinger reported the GPS traveled North on South Park Street, the four recorded GPS locations indicates speeds of 40 mph, 39 mph, 30 mph, and 31 mph as it approached Famous Dave's (900 South Park Street, in the City of Madison, Dane County, Wisconsin).

At 9:02 P.M. the GPS stopped moving. Trollinger showed Detective Davis a screenshot of the plotted coordinate, which plotted on the North side of the North parking lot of 900 South Park Street. The plot indicated an HDOP of .8 with 9 satellites in solution and a 30 ft position of accuracy.

At 9:03 P.M. the GPS heads West through the North parking lot at 9mph. Trollinger showed Detective Davis the GPS plot and Detective Davis saw that it had an HDOP of 1.2, 7 satellites in solution, and a 33ft position of accuracy.

At 9:04 P.M. the GPS plot is stationary in the West (back lot) of 900 South Park Street). The GPS plot indicated an HDOP of 1.0, 8 satellites in solution, and a 23 ft position of accuracy.

At 9:05 P.M., the GPS is headed southbound on South Park Street, South of 900 South Park Street at 47 MPH with and HDOP of 2.8, 5 satellites in solution, and to a 69 ft. position of accuracy.

At 9:06 P.M., the GPS continues south on South Parks Street at 45 MPH. The GPS then continues South on Park Street, East on the beltline, North on 90, West on 30, until returning to 3222 Burke Avenue at 9:21 P.M.

The GPS remains at 3222 Burke Avenue until approximately 10:41 P.M.

The GPS is in motion until approximately 10:51 P.M. when it stops near 1 Rustic Ridge Court.

The GPS again goes back in motion at approximately 10:52 P.M.

Officer Olson reports on May 31, 2018, he assisted in taking Juwan J. Wilson, the defendant, into custody. While waiting with Wilson, Wilson at one point asked Officer Olson something to the effect that a person can make a report with the police if they have had their marijuana taken from them. Wilson specifically had started out this inquiry about being told that this involved a robbery. Officer Olson told Wilson that in fact nothing in the statute prohibited the officers from investigating or charging anybody for taking somebody else's property that they were not legally allowed to possess and/or sell.

Detective Davis reports on May 31, 2018, at approximately 11:00 A.M., he responded to an address located on Leopold Way and made contact with a female identified with a name that forms the initials ZNJ. Detective Davis asked ZNJ if she knew a man who Detective Davis identified with a name that forms the initials MAN. ZNJ stated that she did. Detective Davis asked ZNJ who MAN was to her. ZNJ stated that she went on a date with MAN and then was also his Uber driver one time. ZNJ stated she had gone out with MAN approximately one month ago. ZNJ stated that MAN new where she lived, but did not know which apartment she lived in. Detective Davis asked ZNJ if she stayed in contact with MAN after their date. ZNJ stated he texted her approximately once a day. Detective Davis asked if she still spoke with MAN, and ZNJ stated she did not. Detective Davis asked ZNJ if MAN had told her about what

had happened to him at Famous Dave's, and ZNJ stated he did. Detective Davis asked ZNJ what MAN had told her about the incident.

ZNJ stated when she first met MAN he was bragging about how he sells drugs. ZNJ stated she was not with KR, but KR had called or text her asking if she knew someone that would sell her weed. ZNJ stated contacted MAN and gave him a female's name that forms the initials KR, and KR's phone number. Detective Davis clarified with ZNJ that the day she gave KR's phone number to MAN was the day that MAN had been shot. ZNJ stated that it was. Detective Davis asked ZNJ if she knew where she was when KR called or texted her about finding someone to sell her weed. ZNJ stated she did not remember and thought that she may have been at work.

Detective Davis asked ZNJ if KR was with anyone when setting up the deal. ZNJ stated she was with Juwan Wilson, the defendant herein. Detective Davis asked ZNJ how she knew this. ZNJ stated that KR had told her.

Detective Davis reports he asked ZNJ about the phone call she received from Juwan Wilson, the defendant, after the shooting. Detective Davis told ZNJ that he assumed it was the night of the incident. ZNJ stated that this was correct. ZNJ stated that Wilson and KR went to the drug deal. ZNJ said that MAN and his friend got into the car. She said that Wilson was handed a box and he thought that it was a scam. She stated that Wilson was arguing with the boys. She said that they got out of the car and that was when Wilson shot them.

Detective Davis asked ZNJ if Wilson said why he shot them. ZNJ stated that Wilson thought that they were not actually trying to sell him weed and they started arguing. She stated she was not certain if MAN ever got the money. Detective Davis asked ZNJ what Wilson specifically said about the shooting. ZNJ said Wilson said that "dude" got out of the car and that he shot or "popped" one of them. Detective Davis asked ZNJ if it sounded as if Wilson made it sound like an accident or it accidentally went off. ZNJ stated that it did not.

Detective Harris reports on May 31, 2018, she made contact with a female who was identified with a name that forms the initials KR, reference the shooting that had occurred on April 21, 2018, in the parking lot of Famous Dave's Barbeque, in the City of Madison, Dane County, Wisconsin.

Detective Harris reports while speaking with KR, KR appeared upset and had tears in her eyes. Detective Harris reports asked KR what she believes Juwan Wilson's, the defendant's, plans were that night. KR answered, "To buy weed." Detective Harris asked KR what happened during the attempted buy. KR answered, "Exactly what you described." Detective Harris asked if it was Wilson's plan all along to do a drug rip during the weed buy. KR answered that she didn't know. Detective Harris asked KR what she thought the plan was when she agreed to drive Wilson to the buy. KR answered that she was just going there to get some liquor. KR explained that at the time of this incident, she was not yet 21. She stated that she went there thinking that in addition to the weed for Wilson that this man would buy her some alcohol. Her understanding was that he was going to buy her liquor at a liquor store on Park and then give it to her at the deal.

Detective Harris asked KR what happened when she got there. KR stated that Wilson tried to take the weed from the dealer. Detective Harris asked when Wilson pulled the gun. KR stated



that after Wilson got the weed, he pulled the gun on the two individuals. Detective Harris asked what Wilson said. KR stated she didn't remember.

Detective Harris asked what the two guys did. KR replied that they both got out of the car. Detective Harris asked what Wilson did at this point. KR stated that they left. Detective Harris asked specifically about what he did with the gun. KR stated that Wilson shot the gun. KR added that she didn't believe he did it on purpose. She stated that Wilson was smacking one of the guys with the gun, and it went off. Detective Harris asked which of the two individuals Wilson was smacking. KR stated that Wilson smacked the "one they'd been conversating with." KR stated that this victim was just sitting in the car at the time this occurred. She stated he was sitting behind Wilson. Richard stated that he got shot as he was attempting to get out of the car.

Detective Harris asked KR if she knew the man who had come with the person she had talked to on the phone. Detective Harris described this person as the one who had brought the pot with him. KR stated she did not.

Detective Harris asked what happened next. KR stated that Wilson told her to drive off. Detective Harris asked KR what she was thinking at this time. KR explained, "I don't know. I was shaking." Detective Harris asked KR what she did after the incident. KR stated she went home. Detective Harris was aware that the investigation showed the suspect had travelled to the northeast side of Madison. Detective Harris asked KR if she had taken Wilson somewhere. KR stated that she did drop Wilson off somewhere on the northeast side but didn't know where.

Detective Harris asked if they had gone to Rustic Ridge. KR stated that was where Wilson asked her to drop him off. She stated she didn't know who Wilson was going to see. Detective Harris asked if she took him to the first or second house on that block of Rustic Ridge. KR stated that she didn't know as it was very dark. KR said she did not go inside but simply dropped Wilson off. Detective Harris asked if she knew where Wilson went after that. KR stated she did not. Detective Harris asked if she was familiar with anybody on Burke Avenue. KR stated she does not know that street.

Detective Harris asked KR what Wilson did with the gun. KR stated she does not know. She stated that the gun was with Wilson when she dropped him off, but she does not know what happened to it after that. KR described the gun as a black gun but stated she is not a gun person, and she doesn't know what type of gun it was. KR stated that Wilson pulled the gun from around his neck. The way KR described it, it appears as though Wilson had the gun on a cord around his neck, tucked inside his shirt.

Detective Harris asked KR if she had seen the casing that came out of the gun after it was fired. KR stated that she did not ever see the casing. Detective Harris asked KR if she had found one in her car later. KR stated no. KR explained that she had cleaned her car since that incident and had not found anything. KR stated that her car was in fairly clean condition the night of the incident and therefore, she did not believe the casing would have gotten lost in items kept within her car.

Your complainant has reviewed the computerized record of the Clerk of the Dane County Circuit Court in the case of State of Wisconsin vs. Juwan J. Wilson, Case Number

2018CF000682. The record reveals that the above-named defendant was charged on April 10, 2018, with the Felony crime of Strangulation and Suffocation, contrary to Sections 940.235(1) and 973.055(1) of the Wisconsin Statutes, and that the charge has not been dismissed and was pending on April 21, 2018. The record also reveals that the above-named defendant was released on bail pursuant to Chapter 969 of the Wisconsin Statutes on April 10, 2018, and that as a condition of release, the Dane County Judicial Court Commissioner ordered, among other conditions, that the defendant shall not possess any type of dangerous weapon. Your complainant is aware that Section 969.03(2) of the Wisconsin Statutes provides that as a condition of release in all Felony cases, a person so released shall not commit any crime.

Your complainant believes the records of the Dane County Circuit Court to be accurate and reliable inasmuch they are records kept and maintained in the normal and ordinary course of business of the Dane County Circuit Court, and your complainant has relied upon such records in the past and has found them to be accurate and reliable.

**\*\*THIS COMPLAINT IS BASED ON** the information and belief of your complainant, who is a Detective for the City of Madison Police Department, and who learned of the above offense from the reports of City of Madison Police Department Police Officer Justin Cumley, Detective James Grann, and Detective Glenn Davis, Officer Shane Olson, and Detective Justine Harris, which report your complainant believes to be truthful and reliable inasmuch as they were prepared during the course of the officer's official duties.

Further, your complainant believes the information furnished by CLS; MAN; KR; ZNJ; and Rebecca Trollinger to be truthful and reliable inasmuch as they are citizen informants and witnessed the events described.

Your complainant believes the statements of the Defendant to be truthful and reliable insofar as they are admissions against penal interest.
