This report is written by **Detective Guy FRALEY**, SCD, Day Shift.

On 11/5/25, at approximately 1:45 pm, **Detective Andrew HOLZEM** and I conducted follow up regarding a 4th Degree Sexual Assault case where the **victim (Jose PEREZ)** had his buttocks pinched or squeezed by the **suspect (Marty BROOKS)**, while at MO's restaurant located at 720 N. Plankinton Ave, on 10/22/25, at approximately 6:15 pm. The follow up consisted of conducting a One-Party Consent Call with the permission of and participation of PEREZ.

The call was completed at Sensitive Crimes Division (Room # 2052), on 11/5/25, at 1:50 pm. I was present with Detective HOLZEM and PEREZ. The call was made from **PEREZ' cell phone of Marty BROOKS**.

The phone rang once and was picked up. **The person answering the phone identified himself as Marty BROOKS**. The following is a synopsis of the recorded call and is not a word for word account of the phone call:

**BROOKS** – GOOD AFTERNOON, MARTY BROOKS

**PEREZ** – Marty BROOKS, Jose PEREZ.

**BROOKS** – President PEREZ, what can I do for you today?

**PEREZ** – Well Marty, um, I'm calling because um and we need to talk about a what happened at a David CRAWLEY'S fund raiser and I didn't go to the board meeting on Friday and um, I feel super uncomfortable about what happened and think we got to talk about this, a before, you know, I come back to a board meeting or do something because I'm uncomfortable about what happened.

**BROOKS** – Tell, tell me what you're uncomfortable with, what happened? That I attended?

**PEREZ** – It's what you did to me Marty, when we were

**BROOKS** – What did I do?

**PEREZ** - When we were standing at, when we were standing, talking, um, it's what you did to me and I'm, I'm totally uncomfortable with that.

**BROOKS** – If I did anything to make you uncomfortable, it was purely by accident and I, I, I apologize profusely and at a loss what I did or what position I may have put you in so please share with me.

**PEREZ** – Marty, Marty, we're adults, you know what you did.

**BROOKS** – Yeah, I, sir I do not. I am at a complete loss what you're calling about. I was speaking with you and I, I don't recall saying anything that was in

**BROOKS** – Sir, I don't know what you're talking about. Tell me what I did, I truly don't know, and, and, so if I did something to offend you or put you in an uncomfortable position, I need to know because I, I would never do anything to put you in an uncomfortable situation or myself as well, so if you would please share with me what I did that offended you or put you in an uncomfortable position.

**PEREZ** – Marty, I, I'm telling you, you know what you did. I was standing next to you. You, it is, I did not go to the board meeting on Friday because I did not, I felt totally uncomfortable and it's not what you said, it's what you did and you know what you did Marty.

**BROOKS** – Sir, I, I don't know what you're talking about and there was no board meeting that I'm aware of this past Friday.

**PEREZ** – Okay, well, the notice went out. I thought there was a board meeting, they asked me if I was going to attend it and I didn't respond at all. I thought it was this past Friday but I am just completely taken back that you're acting like you don't know what I'm talking about.

**BROOKS** – Sir, I do, I have no clue what you're talking about. That's why I need you to tell me because if I did something that was inappropriate or offended, I, I, I don't want to do it again and I cannot recall anything that I did that was inappropriate or, or offensive so please, and if you're uncomfortable telling me, tell it to \_\_\_\_\_ and she'll tell me but I would never do anything knowingly that, that would put anybody in a bad situation. So if you're calling me to tell me I did that, please complete the story so I can be aware of it.

**PEREZ** – \_\_\_\_\_ saw what you did too.

**BROOKS** – Well, then I'll call her right now because I'm at a completely at a loss of what I could have done, and, and the fact that you won't tell me even concerns me because I want to adjust the behavior if it was offensive.

**PEREZ** – Okay, um, I, I, I'm, I'm, I'm disappointed that you're acting like you don't know what you did. I really

**BROOKS** – Sir, well, you know, I, I appreciate that you're calling me to tell me that I did something inappropriate in your presence. Ah, the, the fact that I don't know what it

**PEREZ** – The fact, the fact that you're acting that way and you want me to tell you that you pinched my butt.

**BROOKS** – Oh come on, I did not do that!

**PEREZ** – You did to.

**BROOKS** – That, that is bullshit, no sir I did not do that! No sir! And I take offense that you're, you're telling me this now! I did nothing to touch you sir! If I did anything, I would have touched you on the shoulder in an affection manner! I do not touch people inappropriately sir! So there may have been someone else in the area around us but it was not me and I will talk, I will talk to \_\_\_\_\_ and find out about it, cause I'm insulted that you're accusing me of that!

**PEREZ** – Well, um that's what happened, and so um

**BROOKS** – Okay, well, I, I, I, look, I cannot refute what you think happened and I apologize for losing my temper and if you choose to bring that to the board, I respect that, you have every right to it. I'm going to call \_\_\_\_\_ because I, I did not do anything a in that regard, nothing sir. And if you think I did, I am so, so sorry but that is not something that I do. And, and I apologize if you think I did it, I know I did not but I certainly um, a will take a, I can't take responsibility for something that I did not do. I, I apologize if you feel that I did that, I did not do that sir.

PEREZ ended the phone call at 1:56 pm. The recording was six minutes and fifteen seconds in duration.

At the conclusion of the phone call, Detective HOLZEM took photos of PEREZ' phone, specifically his text conversation with [REDACTED] regarding. The text message conversation that was photographed reads as follows:

**PEREZ** – Wednesday, Oct 22 8:18 PM

Need to talk to you. Please let me know when.

– 8:18 PM SMS

Two red exclamation points

**PEREZ** – Saturday, Oct 25 3:47 PM

Thanks but can't make play. Forgot to let you know yesterday for

You are welcome!

**PEREZ** – Sunday, Oct 26 11:17 AM

We need to talk

This report is written by **Detective Guy FRALEY**, SCD, Day Shift.

On 11/6/25, at approximately 1:30 pm, **Detective Andrew HOLZEM** and I conducted follow up regarding a 4th Degree Sexual Assault case where the **victim (Jose PEREZ)** stated that his buttocks was pinched or squeezed by the suspect (Marty BROOKS), while at MO's restaurant located at 720 N. Plankinton Ave, on 10/22/25, at approximately 6:15 pm. The follow up consisted of locating and interviewing a possible **witness** , W/F,

Detective HOLZEM and I arrived at \_\_\_\_\_ and knocked on the door. \_\_\_\_\_ answered the door and invited us inside. I asked \_\_\_\_\_ if she had any idea why we were there to speak to her and she stated that she believed that it might have something to do with President PEREZ and Marty BROOKS. I informed her that was the reason that we were there to speak to her and asked her if she could tell us what she witnessed.

\_\_\_\_\_ stated that she was at a fundraiser located on the second or third floor of MO's restaurant (720 W. Plankinton Ave). She stated that she arrived with \_\_\_\_\_ and upon getting to the second or third floor, she was standing kind of in a circle with \_\_\_\_\_ and began talking to Marty BROOKS and President Jose PEREZ. She stated that they were talking for approximately ten minutes when she observed Marty BROOKS reach his hand towards President PEREZ' buttocks. She stated that she did not see BROOKS' hand make contact with PEREZ' buttocks but she did observe his hand moving in that direction and believed that he did touch his buttocks. She stated that it was a quick motion or touch and it did not appear to her that BROOKS was attempting to caress or keep his hand on PEREZ' buttocks. She stated that they were having a good-natured conversation and neither BROOKS or PEREZ appeared to be angry before or after the incident. She stated that she does not remember exactly what they were talking about but she remembers that they were laughing and everything seemed to be fine. She stated that she was not intoxicated and that PEREZ and BROOKS did not appear to be intoxicated. She stated that she thought it was unusual or weird but she quickly forgot about it as the three of them continued to talk. She stated that they continued to talk for approximately five more minutes and then PEREZ left the restaurant to go to the Milwaukee Bucks game with \_\_\_\_\_

stated that she didn't think any more about it until PEREZ arrived back at the fundraiser a couple of hours later. She stated that PEREZ was with [redacted] and [redacted]. She stated that PEREZ asked her if she observed what Marty BROOKS did and she stated that she did. She stated that they did not really talk about it but she realized that it bothered PEREZ.

stated that she didn't really think about it again until she received a phone call from Marty BROOKS on Wednesday (11/5/25). She stated that BROOKS asked her what PEREZ was talking about. She stated that she informed BROOKS that he touched PEREZ' buttocks while he was talking with his hands and BROOKS sounded shocked. She stated that BROOKS became extremely emotional and asked her to fix it.

stated that she attempted to call PEREZ but he didn't answer his phone.

stated that she is close to BROOKS and to PEREZ. She stated that she feels bad that she is caught in the middle of this situation. She stated that she feels bad for BROOKS who is upset and she feels bad for PEREZ who is obviously upset about what happened.

Detective HOLZEM and I thanked [redacted] for taking the time to speak to us and left her with our contact information.

Detective Andrew Holzem assigned to the Sensitive Crimes Division day shift wrote this supplemental report. On Wednesday November 5, 2025 at approximately 10:30 am Lieutenant James Floriani instructed me to interview Jose G. Perez (W/M, ) regarding a walk-in sexual assault complaint. Detective Guy Fraley interviewed Perez with me. The interview took place in room 2048 of the Sensitive Crimes Division.

Perez identified himself as the President of the City of Milwaukee Common Council and the Alderman of District # 12 in Milwaukee. Perez stated on October 22, 2025 he was attending a fundraising event at Mo's Steakhouse located at 720 N. Plankinton Avenue for Milwaukee County Executive David Crowley's Governor's campaign. Perez stated he was at the event on the third floor. He was sitting on a couch with and next to him. He stated Marty Brooks, the President and CEO of the Wisconsin Center District walked in with and . Perez stated is a consultant who works with Marty. Perez stated also does consulting work for WE Energies and Children's Hospital of Wisconsin. Perez stated everyone was standing in a close circle making small talk about the Brewers. Perez stated Marty talked about how Alderman Bauman wanted to designate the Milwaukee Panther's arena as a historic site and how he did not like that because it would make it difficult for him to make changes to the building. Jose stated that he told Marty that he should bring his concerns to the common council.

Perez stated as the group was talking someone said something funny or cute. He did not remember what was said or who said it. He stated at that time Marty who was standing to Perez' left in close circle reached over and pinched Perez' left buttock with Marty's right hand (fingers). Perez stated he could feel a sharpness from Marty's fingernails as Marty pinched his butt. Perez stated after Marty did so he was shocked and he couldn't believe what happened and he was angry, but he did not want to confront Marty in an aggressive way because he did not want anything to become violent. Perez stated as Marty pinched his butt he saw that witnessed what happened. Perez stated thirty seconds to one minute

later he left the restaurant. Perez stated he called \_\_\_\_\_ and she and \_\_\_\_\_ and the \_\_\_\_\_ came and picked him up from the restaurant and they went to the Bucks game together. Perez stated while at the Bucks game he sent a text message to \_\_\_\_\_ at 8:18 pm stating, "Need to talk to you. Please let me know when." Perez stated \_\_\_\_\_ highlighted his message by sending back two red exclamation points which he felt meant that she knew what he was talking about and that she would be willing to talk to him.

Perez stated during the Bucks game the owner of Mo's steakhouse text messaged him asking him to come back to the restaurant. Perez asked \_\_\_\_\_ and \_\_\_\_\_ if they wanted to get a drink at Mo's after the Bucks game and they agreed. Perez stated at 8:45 pm he went back to Mo's steakhouse and when he arrived he saw that \_\_\_\_\_ was still at the restaurant. Marty was not there. Perez spoke to \_\_\_\_\_ after arriving back at Mo's steakhouse. Perez asked \_\_\_\_\_ if she saw what Marty did to him and she stated she did see it and she laughed. Perez stated he wanted to talk to \_\_\_\_\_ more about what Marty did but he did not talk to her further while at Mo's. He exchanged the text message "Thanks but can't make play. Forgot to let you know yesterday \_\_\_\_\_". The text message was sent by Perez to \_\_\_\_\_ on October 25, 2025 at 3:47 pm. \_\_\_\_\_ responded by stating, "You are welcome!" Perez stated the text message was in response to a missed voicemail invitation from \_\_\_\_\_ to \_\_\_\_\_ to go to a play. Perez sent \_\_\_\_\_ an additional text message stating, "We need to talk" on Sunday October 26, 2025. There was no response to the message. Perez stated he gave up on talking to \_\_\_\_\_ mostly due to the way she reacted when he confirmed with her that she saw Marty pinch his butt.

Perez stated during the incident he was dressed in a black bomber jacket and black slacks. He stated Marty was wearing a blue suit. Perez stated he has seen Marty in the past at social events that he attends due to his position as an Alderman. He stated his relationship with Marty is solely a business relationship. Perez stated he has Marty's cell phone number and he has communicated with Marty in the past over the phone for business purposes. Perez last communicated with Marty prior to the incident at Mo's approximately six weeks prior to the incident over the phone. Perez looked at his phone and saw that he and Marty called each other on September 19th and talked over the phone for less than one minute. Perez did not receive any communication from Marty after the incident at Mo's. Perez stated approximately nine months ago He was on a Milwaukee board where Marty's salary as the CEO of the Wisconsin Center District was up for a raise and he voted against giving Marty a raise. Perez stated the overall vote gave Marty a raise anyway. Perez stated there was a black and white ball event on November 1, 2025 that he (Perez) did not intend due to the knowledge that Marty was going to be present at the event. Perez stated he also missed the last board meeting because she thought Marty would be there and he wanted to avoid him.

Perez stated when Marty pinched his butt he felt violated. He felt it was done in a sexual way and also that it was like a "screw you" / "power move". Perez stated he thought about what to do about what Marty did to him and ultimately he decided to do what he would recommend anyone do if they were in the same situation so that is what caused him to report the incident to police.

OUT OF CUSTODY INTERVIEW OF MARTY BROOKS

Detective Andrew Holzem assigned to the Sensitive Crimes Division day shift wrote this supplemental report. On Thursday November 6, 2025 at approximately 3:01 pm Detective Guy Fraley and I conducted an out of custody interview of Marty Brooks (W/M). The interview took place inside a conference room in the administrative offices of the Baird Center. Prior to the interview I called Brooks who offered to meet at his office to speak to us.

I introduced Detective Fraley and myself and told Brooks that we worked for the Milwaukee Police Department. I also stated to Brooks that we were talking to him voluntarily and that he was out of custody and he could end the interview and tell us to leave at any time. Brooks stated he invited us there and he was talking to us willingly.

Brooks stated he had a conversation on the previous day with President Perez. Brooks stated he received a phone call from Perez. He stated Perez called him at 1:52 pm on 11/05/2025. Perez stated he had an issue with him because of something that occurred at David Crawley's fundraiser at Mo's steakhouse. Brooks stated he was caught off guard because he had not thought about the fundraiser since he was there. Brooks stated he had no idea what Perez was talking about. Perez kept telling him he (Marty) knew what he did. Perez stated that \_\_\_\_\_ was there and saw what he did and that she thought Brooks touched Perez buttocks. Brooks stated he kept asking Perez what he did and he suggested that if Perez was uncomfortable telling him that he could tell \_\_\_\_\_ what he did. Perez told him that he didn't go to the last board meeting because he was uncomfortable. Brooks stated he told Perez to bring his concerns to the board. Perez then told Marty that he pinched his ass. Brooks stated at that point he leapt out of his chair and he didn't know what he said verbatim but he said something to the effect of, "You gotta be fucking kidding me, what are you talking about." Brooks stated he did no such thing. Brooks stated he was yelling because he was taken back and caught off guard. Brooks stated he told Perez he was sorry that he felt that way but it didn't happen. Brooks stated Perez ended the call abruptly.

Brooks stated he called his attorney and spoke about what Perez stated. He then called [redacted] who stated she remembered the conversation which was business related. [redacted] stated she saw Brooks touch Perez but she didn't think anything of it. He then placed a third call to his Vice President of Human Resources and directed there to be an investigation. Brooks asked if there was video of what he did and if there was he wanted to see it so he didn't do it again. I asked Brooks if there was any issue between him and Perez. Brooks stated he and Perez are acquaintances and they have done business and had meetings together. He stated he has never been out with Perez socially and their relationship is only professional. Brooks stated he has no ill will and no issues with Perez. Brooks stated it was possible that he touched Perez' arm while talking with his hands but he adamantly denied ever touching or pinching Perez' butt at any time. Brooks stated he was not intoxicated during the incident and he rarely ever drinks. He stated he was drinking club soda at the event at Mo's. Brooks stated he has never previously been accused of doing anything like this. The interview concluded at 3:46 pm

On 11/7/25, at approximately 12:00 pm, **Detective Andrew HOLZEM** and I conducted follow up regarding a 4th Degree Sexual Assault case where the **victim (Jose PEREZ)** stated that his buttock was pinched or squeezed by the suspect (Marty BROOKS), while at MO's restaurant located at 720 N. Plankinton Ave, on 10/22/25, at approximately 6:15 pm. The follow up consisted of locating and interviewing **disclosure witnesses** **H/F, and H/M,**

Detective HOLZEM and I arrived at the \_\_\_\_\_ residence and they invited us inside of their home. Detective HOLZEM and I were invited to sit at their dining room table where we interviewed both witnesses.

and \_\_\_\_\_ informed us that they were not sure what the exact day was but they know that it was the day that the Milwaukee Bucks had their first home game. They stated that they were with \_\_\_\_\_ and they picked up the victim from MO's restaurant. They stated that they drove the victim and \_\_\_\_\_ to the Bucks stadium and they were watching the game together. They stated that during halftime, they stood up and began walking towards the restaurant within the stadium when the victim informed them that a guy pinched his ass earlier in the evening while he was at Mo's restaurant. They stated that the victim did not appear to be angry but he did appear to be shocked and it appeared that the incident did bother him. They stated that the victim appeared to be thinking about the incident as they changed the subject and began making small talk about other things.

and \_\_\_\_\_ stated that the victim only mentioned the incident and did not talk about the details or who was involved in the incident.

and \_\_\_\_\_ stated that a short time later, the victim asked them if they wanted to go back to Mo's restaurant with him and get something to eat. They stated that they left the Milwaukee Bucks game early

She stated that the victim came out of Mo's and got into the backseat of vehicle with her. She stated that while the were driving them to the stadium, the victim stated that Marty pinched his butt. She stated that the victim stated "you're not going to believe this, Marty pinched my butt". She stated that the victim appeared to be in disbelief and she asked the victim if Marty was drunk. She stated that the victim immediately responded "don't know, does it matter?" She stated that the victim stated that he didn't want to talk about it anymore and that was all that was said while they were in the car. She stated that she was not sure if the overheard her and the victim talking about the incident while they were inside of the car.

stated that it was briefly discussed while inside of the stadium at the Bucks game. She stated that she knows that the were a part of that brief discussion but she doesn't really remember what was said other then the victim informing them that a man pinched his butt while at Mo's restaurant.

On 11/6/25, at approximately 3:00 pm, I conducted follow up regarding a 4th Degree Sexual Assault case where the **victim (Jose PEREZ)** stated that his buttock was pinched or squeezed by the suspect (Marty BROOKS), while at MO's restaurant located at 720 N. Plankinton Ave, on 10/22/25, at approximately 6:15 pm. The follow up consisted of responding to Mo's Steakhouse located at 720 N. Plankinton Ave in an attempt to locate surveillance video regarding.

Upon arrival, I observed that the doors were locked. I knocked on the doors and nobody answered. I then called the restaurant and spoke with an unknown female who informed me that the manager would begin working at 5:00 pm or 6:00 pm.

At approximately 6:00 pm, I called and spoke to the **Mo's Steakhouse** who asked me what I was investigating and I informed him that we were investigating one person touching another person inappropriately while being on the third floor of his restaurant. informed me that they did not have surveillance cameras on the third-floor dining room yet because it was recently remodeled. He stated that there are video cameras in the third-floor hallway. He stated that he believes that the video only keeps for approximately a week and he informed me that I would have to contact the ( ) who has access to the surveillance video for the entire building. He gave me contact information.

stated that he does not believe that this could have happened on the third floor because he doesn't allow just anybody on the third floor of his restaurant. He stated that he only allows certain people on the third floor and they have to have special access to get onto the third floor.

I thanked [redacted] for his cooperation and ended the phone call.

On 11/7/25, I called [redacted] and discovered that she was out of the office until 11/14/25. I was able to speak to [redacted] who is also a building manager but was working from home. She informed me that she believed that the surveillance video remains in the system for approximately three to four weeks. She informed me that there are no surveillance cameras in the third-floor dining area of Mo's Steakhouse but stated that there are cameras in the hallway of the third floor. She stated that there are no entrance cameras that would capture who is coming or going from Mo's Steakhouse. She stated that there are main entrance building cameras that capture people entering the building but the video does not reveal if the person entering the building then enters Mo's Steakhouse. She informed me that she would be back to working in the office on 11/11/25, from 7:00 am to 4:00 pm and she would allow me to view the surveillance cameras at that time.

On 11/11/25, at 9:00 am, I called and spoke to [redacted] who informed me that she was stuck in Indiana due to the large amount of snowfall that they received on the previous couple of days. She stated that she was currently on her way back to Milwaukee and would be back in her office on 11/12/25, from 7:00 am to 4:00 pm. I informed [redacted] that I would call her on 11/13/25 to try to set up a time to meet and then I ended the call.

On 11/12/25, at approximately 11:00 am, I met with [redacted] who showed me the two exterior video angles that cover MO's Steakhouse entrance / exit. I observed that one of the angles is located south of MO's entrance and faces south, which would capture people walking north towards the entrance but would not clarify who enters or exits MO's Steakhouse. I observed that the second camera is located to the south of MO's entrance / exit but points towards the entrance. It is a decent distance away from the entrance / exit and makes it difficult to identify who walks in or out of MO's Steakhouse. She informed me that they did not have any cameras in MO's Steakhouse and did not have any cameras in the third-floor hallway of MO's Steakhouse.

I asked [redacted] if I could obtain the video from 10/22/25, 6:00 pm to 8:00 pm and she informed me that she did not have the ability to download the video but would have her IT personnel download it to a thumb-drive and she would call me when it was ready for pick up.

I then changed locations to MO's Steakhouse and asked for [redacted] The unknown employee that I was speaking to called [redacted] by phone and I spoke to him. He informed me that he does not have any cameras inside of the restaurant but has recently

On 11/14/25, at approximately 9:00 am, I spoke to (Zilber Property Group) by phone and she informed me that the surveillance video was burned to a thumb-drive and was ready for pick up.

At approximately 11:00 am, I arrived and parked in front of 710 N. Plankinton Avenue. As I parked, approached my squad car and handed me a thumb-drive, her business card and informed me that the video was burned from 6:00 pm to 8:00 pm as requested. I thanked for her help and ended the contact.

On 11/19/25, I viewed the surveillance video and observed that thumb-drive contained two exterior video angles.

Camera #1 was affixed to the exterior of the building at an elevated position, south of the main building door (710 N. Plankinton Ave), pointing to the northwest, which covers the area of MO's main entrance door and Plankinton Ave. I observed the following on Camera #1:

-At 4 minutes and 20 seconds into the video, a purple four door Hyundai car pulls up and stops in front of MO's Steakhouse and it appears that exits the rear passenger door of the vehicle followed by a middle-aged white male and both walked into MO's Steakhouse.

-At 34 minutes and 52 seconds into the video, it appears that the victim exits the exit of the main

building exit (710 N. Plankinton Ave), walks north as he crosses Plankinton Ave, turns and walks south down Plankinton Ave until he's out of camera view.

Camera # 1 was 2 hours and 3 minutes in length and I did not reveal anything of evidentiary value on the video. It should be noted that I did observe several people that were similar in appearance to BROOKS but I could not definitively say that the subjects were BROOKS.

Camera # 2 was affixed to the exterior of the building at an elevated position to the north of the main building entrance / exit located at 710 N Plankinton Ave, pointing to the southwest, which covers the building's main entrance, a portion of N. Plankinton Ave and the W. Wisconsin Ave / N. Plankinton Ave intersection. I observed the following on Camera #2:

-At 34 minutes and 17 seconds, I observed the victim exit the main entrance / exit doors to the main building located at 710 N Plankinton Ave. The victim walked north out of camera view and seconds later re-appeared walking south on N. Plankinton Ave where he entered the rear driver's door of a silver SUV, which then drove north out of camera view.

I did not observe anything else of evidentiary value on Camera # 2 and it was 2 hours and 7 minutes in length. It should be noted that I did not observe the victim arriving on video and at no time did I observe BROOKS on video.

The thumb-drive was placed on MPD Inventory # C25 11050059, Item #1.
